A motion to accept the report was made by Harold Mangler and seconded by Ray Dobbs. There was no discussion. The motion was carried unanimously.

<u>COMMITTEES</u> – <u>Sunshine Committee</u> – The Secretary reported that Joe Rahl is home from the hospital. Karen and Bob Slater's son Eric died of an apparent heart attack yesterday. Helen McDermott notified the association that Joe is doing well and would love to have members stop by. Cards for Joe Rahl, John O'Hare, and Bob Slater were signed by the members.

<u>Benefits Committee</u> – Copies of the March 2019 Dahab Report from yesterday's Retirement Board meeting were distributed to the members present. The Secretary reported that the plan is doing very well according to Dahab representatives and is currently valued at \$165.6 million. He also reported that the attorney for the Retirement Board, Marc Wallman, announced that the board will be investigating the town's COLA error over the course of more than 20 years to see what recovery efforts may be permissible. A lengthy discussion ensued.

The Chair also mentioned that the HGSRA will be looking into the Medicare Reimbursement issue. Honorary member Lucianne Kenyon reported that her late husband Ricky had saved the retirement agreement under which he retired. The wording in the agreement she has states that the reimbursements are to be done quarterly. She will send a copy of the agreement to the Secretary when she returns home to Florida.

<u>History Committee</u> – Schoolhouse – The Secretary reported that Tom Doherty, Vic Mitchell of Co. 7, and he met with representatives from the Mayor's Office on January 24<sup>th</sup> and were reassured that the \$50K that had been placed in a capital account to rehab the old schoolhouse is still there. The committee requested another walk-through of the building. The Mayor said he would like to wait until after the budget hearings are over before taking any action on the schoolhouse.

The Secretary reported that the weekly website updates will be discontinued at the end of June, but the website will continue as a bulletin board, with each month's postings being archived.

<u>**OLD BUSINESS**</u> – Harold Mangler suggested some sort of honorarium to the officers, which the officers declined with their thanks.

<u>NEW BUSINESS</u> – The Secretary requested that a letter of thanks be sent to Local 2687, once again expressing the association's thanks for retirement dinner invitations to all retirees and widows, and its appreciation for the hard work done by the dinner committee, Kevin Recca and Brian Gilson.

The fireworks will be held again this year, although this time it will be orchestrated by the town. It will be held Friday, June 28th.
