The Secretary then presented the Annual Treasurer's Report for 2019, which is included with these minutes.

A motion was made by Harold Mangler, seconded by Ray Dobbs, to accept the Treasurer's reports. Motion passed unanimously.

<u>COMMITTEES</u> – <u>Benefits Committee</u> – The Chair reported on the town's intention to recoup the funds that were overpaid to retirees until May 1, 2012. He noted that a meeting of the Retirement Board is this afternoon at 3. He reviewed the reasons for forming the HGSRA in 2012 to protect our pensions and benefits. The HGSRA E-Board believes the town is wrong and have received pro bono advise from an attorney and from an accountant.

That HGSRA E-board does not dispute that the Retirement Board has a fiduciary responsibility to recoup the overpayments, but the E-Board does take issue with the town's not addressing this issue as far back as 2002, when they were first made aware of the problem. The town has given the HGSRA no indication as to how they are going to address this problem. We are also not sure if we will receive a COLA on May 1. [Note: Retirees did receive a COLA on May 1, 2020.]

<u>Sunshine Committee</u> – The Secretary reported that there was a good turnout of retirees to stand Honor Guard for Joe McDermott and Joe Rahl.

In the recent municipal elections, Bob Viglione won the most votes of the North Branford council members and thereby has become Mayor of that community.

Condolence card to the family of Tom Doherty, whose son Tom passed away just before Christmas.

Several retirees assisted our active members in the annual Thanksgiving turkey distribution at the Senior Center and M.L. Keefe Center.

He and Tom Doherty visited member Clark Hurlburt in late November as he was recuperating from open-heart surgery.;

With Kurt Vogt's recent promotion to lieutenant, the new Badge #1 Firefighter is Don Pazcowski.

The memorial video has been revised and is presently on YouTube.

The Chair just received word that today's Retirement Board has been cancelled due to it being a holiday.

The Secretary reported that Bill Fitzmaurice's son Bill was just appointed to the department.

<u>History Committee</u> – The Secretary noted that it was Harold Prescher who was solely responsible for the adoption of a department map book when, as a new recruit in 1981, he made his own map book that was soon adopted by the department and placed in all apparatus.
